Executive Board Meetings

- Executive Board Meetings since May 2014
 - 19 June 2014
 - 12 September 2014
- The minutes of all Board meetings are published after every meeting
- A summary of the discussions and decisions made are also published and announced to members



June Board Meeting

- Discussed the tax implications of any redistribution of surpluses from excess revenue to members
- Updated the RIPE NCC Treasury Statue
- Investigated options to set up a separate fund for "the good of the Internet" initiatives
- Discussed RIPE Atlas and associated costs
- Discussed the RIPE NCC Budget for 2015



September Board Meeting

- Approved Draft Activity Plan and Budget 2015 to present to the membership
- Agreed that members should be asked if they wanted to pay tax or redistribute surplus/deficit
- Approved new RIPE NCC Standard Service Agreement for members to vote on
- Drafted resolution to outline actions in the event of sanctions being imposed on a country in the service region



Impartial Service Delivery

- RIPE NCC is committed to providing uninterrupted service to our entire service region regardless of political discussions or disputes
- Executive Board published a resolution on continuity of services to all RIPE NCC members

- RIPE NCC staff are neutral in delivering services regardless of any political situations
- We will publicly document all efforts to ensure that provision of our services are not disrupted



Member Discussion on Voting

- Four suggestions for changing processes
 - Removing paper votes
 - Removing proxy votes
 - Removing voting by acclamation
 - Extending the voting window
- No clear support for first three suggestions
- Voting window is now extended to 09:00 Friday
- Results of voting will be announced 10:45 Friday
